**SCOPE AND CONTENT**: The Charles Affleck Collection contains a variety of materials concerning the Civil War, numismatics, and the history and economic life of Winchester and Frederick County, Virginia.

**BIOGRAPHICAL/HISTORICAL**: Charles Affleck was born in Winchester, VA on May 3, 1896. He had a long career with General Mills in Atlanta, Georgia, until he retired in 1951 and returned to Winchester. Affleck was an expert in numismatics and an active member of the Winchester- Frederick County Historical Society. His efforts ensured that the Society obtained the Civil War diary of Mrs. Mary Greenhow Lee. He died on September 21, 1974 and is buried in Mt. Hebron Cemetery.
