Most of the materials concern Clarke T. Cooper Sr., and Clarke T. Cooper Jr., both of whom were prominent businessmen in the Winchester area.

**BIOGRAPHICAL/HISTORICAL**: The Coopers are a local Winchester family that are associated with multiple businesses operating out of Winchester. These include a Tailor business—John R. Cooper (1820-1916), A wholesale grocery, W.E. Cooper & Sons (and alternate names)—associated with William Ewing Cooper (1876-1957), Thomas Jefferson Cooper (1853-1933), and Clarke Thomas Cooper Sr. (1903-1957), General Oil Company in Winchester—associated with Clarke T. Cooper Sr., and an architectural firm called Cooper and Auerbach—associated with Clarke Thomas Cooper Jr (1929-2017).

The Coopers were also prominent in Winchester cultural and religious groups such as the Cavalry Baptist Church, Christ Episcopal Church, the Winchester Exchange Club, the Winchester Golf Club, the Henry Evans Home for Children, and the board of directors of the local Apple Blossom Festival.
