**SCOPE AND CONTENT**: The Thomas K. Cartmell Papers contains a wide range of materials concerning the Cartmell family and the history of the Frederick County, Virginia. The collection includes a number of items of correspondence from 1810-1909 to include letters written during the Civil War letters and family letters from the post-war era. The collection also contains family land records (1787-1814), notes on family history (1799-1908), and family ration books from the Second World War.

**BIOGRAPHICAL/HISTORICAL:** Thomas K. Cartmell was born in Frederick County on January 28, 1838, the son of Mordecai B. Cartmell and Eliza Campbell. He married Annie Glass Baker and had two children, one of whom died in infancy. Cartmell served as a U.S. Marshal in Texas prior to the Civil War. During the Civil War he served as an assistant quartermaster in Winchester, VA, and as a Provost Marshal. He is also the author of *Shenandoah Valley Pioneers and Their Descendants*, published in 1909. Cartmell died on May 15, 1920 and is buried in Mount Hebron Cemetery in Winchester, VA.
