SCOPE AND CONTENT: The Handley Board of Trustees Records contains information pertaining to the bequest of John Handley which established the Handley Library and the Handley High School. Most of the material consists of financial records and other documents from the Board of Trustees, which was established to manage the funds designated by Judge Handley. There are also documents pertaining to the building, furnishing, and early years of the Handley Library, the Handley High School, and the Douglas School.

BIOGRAPHICAL/HISTORICAL: The Handley Board of Trustees was established February 7, 1896, by the Winchester City Council. The Board was chartered "to carry out the purpose of Judge Handley's will as it relates to the City of Winchester; 'to superintend and direct the custody and investment of the fund' resulting from the said will." In carrying out Judge Handley's will, the Handley Board of Trustees founded the Handley Library (opening in 1913), and the Handley High School (1923) and the Douglas School (1927).

ARRANGEMENT: Materials have undergone only minimal arrangement. Organization generally reflects the order in which they were received.
