- [603-003] 312 West Clifford Street, Winchester, VA. Former Winchester Memorial Hospital. Copied from a postcard, 1930.

- [603-009] Elber Luttrell in US Army uniform, circa World War II, circa 1940s.
- [603-010] Albert Pingley in US Army uniform, circa World War II, circa 1940s.

- [603-012] Mandy L. Farris (Bain), USMC. Note enclosed in envelope gives rank as Corporal from 1964-66, Sergeant (in MC Reserves), place as Shockeysville, VA. The photo must be from the period in Reserves, as she is wearing Sergeant's stripes, 1983-85.
- [603-013] US Marines encamped on Cedar Creek battlefield during maneuvers. From a newspaper clipping. The Marines, under the command of Brigadier General Smedley D. Butler, were en route from New Market, where they had participated in a re-enactment of the Civil War battle, to Winchester, 1923.
- [603-014] Hollingsworth Ford, across the Shenandoah River one mile south of Woodstock, VA. Copied from a postcard, 1930-1988.

- [603-015] US Marines on Valley Pike near Cedar Creek Battlefield. The Marines, under the command of Brigadier General Smedley D. Butler, were en route from New Market, where they had participated in a re-enactment of the Civil War battle, to Winchester, circa September 1923.
- [603-016] Luttrell collection unidentified man. Very young, high standing collar, wide ascot tie, circa mid to late 19th century.
- [603-017] Luttrell collection unidentified Quaker meeting house. Photographic postcard, unused, circa 1910.

- [603-028] Battle of New Market re-enactment, including VMI Cadets and 3500 US Marines under command of Brig. Gen. Smedley D. Butler. Filed as "New Market, battle of, re-enactment," September 20, 1923.
- [603-029] "Long Meadow", in Warren County near Strasburg (in Shenandoah County) and Middletown (in Frederick County), VA. Site selected by Jo(i)st Hite in 1737 for son Isaac Hite. Building shown dates from 1845, constructed on old site by Col. George Bowman (great-grandson of Jost Hite). Owner at time of photograph was S. Edwin Brumback, 1910s.
- [603-030] Wayside Inn, Middletown, Virginia. Originally built in 1797 and known as Wilkinson Tavern. Later purchased by Jacob Larrick and operated as Larrick Hotel. Before and after the Civil War, it was a relay station for Shenandoah Valley stage lines. Has been Wayside Inn since 1908, early 20th century.
- [603-031] Wayside Inn, Middletown, Virginia. Originally built in 1797 and known as Wilkinson Tavern. Later purchased by Jacob Larrick and operated as Larrick Hotel. Before and after the Civil War, it was a relay station for Shenandoah Valley stage lines. Has been Wayside Inn since 1908, early 20th century.

- [603-035] Ebenezer School students, some (not specifically) identified. See People for list, last name first, 1931-1932.
- [603-036] Greenway Court, original manor house built circa 1749 by Lord Thomas Fairfax, sixth Baron Cameron, when he became proprietor of the Northern Neck of Virginia through an inherited grant. From an engraving made some time between 1800 and 1828 (when the old house was replaced by a brick building). Greenish tone is on original postcard, early 20th century.
