SCOPE AND CONTENT: This collection contains materials from a number of military units operating within of the Shenandoah Valley during the French and Indian War, the Revolutionary War, the War of 1812, and beyond. There is also information about the Continental Morgan Guards and their actions while serving at Charlestown during the Brown Raid and trial in 1859. Materials are organized chronologically.

BIOGRAPHICAL/HISTORICAL: During the early 1700s, the British Government and colonial leaders in Virginia began to encourage settlement in the Shenandoah Valley as a buffer against French expansion and attacks from Native Americans. As Virginians began to expand their area of settlement into the Ohio Valley conflict with the French and their Indian allies led to the French and Indian War.

The conclusion of the French and Indian War cemented British control over the North American colonies while at the same time laying the groundwork for future conflict between American colonists and the British Government over westward expansion, among other issues. Tensions between Britain and the new nation persisted after the Revolutionary War erupted again in the War of 1812.

Troops from the Northern Shenandoah Valley participated in all of these conflicts, and evidence of their involvement is present in a number of forts, battle sites, and other landmarks throughout the region.

The Continental Morgan Guard, founded in 1855 in Frederick County, Virginia, and formally known as Company A 31st Virginia Militia, were named in honor of Revolutionary War officer Daniel Morgan. They would later become Company K of the 5th Regiment and serve the Confederacy during the Civil War.
